Greetings Residents,

What a winter! I hope everyone had a chance to enjoy the last eight months!

With the 2013/2014 fiscal year complete, it looks like we were again successful at maintaining a balanced budget. Final numbers are still a few weeks away; however, early indicators are positive.

The New Year is full of opportunity for the Township Board to roll up their sleeves and tackle the big issues. The first issue under review is the ambulance service. Volunteer fire and ambulance departments are struggling to survive. Reality is, the demands of everyday family life are shrinking the number of volunteer hours available to organizations that count on them. Recently, through job relocations, medical issues, retirements, and other restrictions, Whitewater Township Ambulance Service has lost up to 55% of its emergency services personnel during certain times of the day. This significant change has resulted in longer response times, calls answered with less than the required number of personnel for ambulance transports, and even unanswered calls. Because of the importance of this issue, the Township Board took immediate action during 2014/2015 budget discussions to temporarily fund a modified duty crew from the general fund, thus maintaining EMS services to township residents. A community wide discussion on permanent funding will take place soon.

Another topic that has been discussed for many years is a new fire station. Having studied hundreds of pages of documents from three previous subcommittees, and receiving help from several residents, a basic outline of a new Township Owned Fire Station has arrived. More recently, the Grand Traverse Band of Ottawa and Chippewa Indian Tribe has forwarded a draft copy of an intergovernmental agreement and lease for an emergency services building they plan to build on the reservation. The agreement/lease is an invitation to Whitewater Township to combine our efforts with theirs to make the community a safer place for all.

The next matter we need to address are township roads. With the second budget cycle now behind us, a clear pattern of Township expenditures can be presented detailing the money available, from township funds, for summertime repair/replacement. The recently adopted Grand Traverse County Road Millage uses factors such as: General road condition, traffic volume, safety, corridor continuity, and economic development in the area to create a road repair plan. In short, it may be difficult for Whitewater Township roads to qualify.

Your involvement is important to the Township Board! In April we will set the date for a "Town Hall" meeting. The meeting will be an opportunity for Board members to listen while you share your ideas about these issues.

2013 tax season is at a close. Settlement with the County went very well with no corrections or adjustments for our Township. The **2014/2015 Budget** has been completed and a public hearing was held on March 20, 2014 at the Township Hall. The budget process is a lengthy process involving all board members. It is done once a year to plan ahead for the financial well-being and stability of the Township as mandated by state law.

Summer Deferment applications can be found on the Township web page. If you have no internet access, a copy can be obtained from the Treasurer's office. The Summer Deferment is due before taxes are due for the 2014 summer tax season, September 14, 2014. Summer deferments allow you to pay your summer taxes after the September 14th due date without interest. For more information on qualifying for the deferment, contact the Treasurer's office.

Principal Residence Exemptions (PRE) Affidavits (Homestead Exemptions) and **Request to Rescind** are due no later than June 1, 2014. They can both be found on the Treasurer and Assessing web page tabs.

Treasurer's office **accepts postmarks**. **Partial payments** are accepted. When paying by **CASH**, please have the **exact amount** of your tax bill. Remember to mark your return stub if you want a receipt mailed to you. If you do not receive your Summer Tax bill by July 15, 2014, please notify the Treasurer's office so we may send another.



Elk River Chain of Lakes Fishing is About to Get BETTER!

Natural Fish Shelters Installed in Five Lakes in the Chain of Lakes

Intermediate Lake * Lake Bellaire * Clam Lake * Torch Lake * Elk Lake

The Elk River Chain of Lakes Fish Shelters Project is an effort to improve fish habitat and is a collaborative effort of the Three

Lakes Association, The Watershed Center, Antrim Conservation District, Tip of the Mitt Watershed Council, Elk-Skegemog Lake Association, Intermediate Lake Association & Friends of Chain Lakes.

The project began in 2012. The project is intended to provide places where smaller forage fish will have protection from larger predators and help to increase fish numbers and diversity to provide better fishing on the Chain of Lakes. The idea is to provide better opportunities for families to introduce their children to



fishing. These shelters compensate for the lack of important shallow water habitat which is absent from many lakes due to shoreline development. Many of our lakes are already devoid of rocks, woody debris and other natural habitat, making the fish population low and the fishing generally poor.

Installation of 15 sites have been completed on Elk Lake. Ultimately, the goal is to install a set of three fish shelters at each of 80 locations on these five lakes over the next five years. For more information on locations of fish shelters, please visit:



The Whitewater Township Planning Commission has completed the rewrite of the draft Master Plan addressing zoning in our Township. A formal adoption process is underway. This process includes review by the Township Board, notification to neighboring townships, review and comment by our citizens and public hearings. There will be a steady stream of communication on the current status of the plan and next steps throughout the summer. We will be using this newsletter, the township website, newspapers, email and direct mailings for this communication.

Currently, the plan is being reviewed by the Township Board, and the Planning Commission is finalizing the format for publishing. We hope to have the Board's approval to release the plan in the coming months. If you are new to the concept of a Master Plan or its purpose for our local government, I have provided a brief summary below.

The intent of the Master Plan is to guide long-term growth and development for the betterment of our community. It provides an outline for township officials, current or future residents, developers, and businesses. The Whitewater Township Zoning Ordinance regulates all zoning matters. The Master Plan only provides guidance for future zoning matters.

WILLIAMSBURG AMERICAN LEGION POST 289 MOURNS THE PASSING OF

MSgt. Thomas "Tommy" Baggs May 28, 1932 - April 2, 2014

The Deal-Ridgeway American Legion Post #289 Williamsburg, Michigan lost a soldier, a patriot, a fellow Legionnaire, and a friend on April 2, 2014. Tommy passed peacefully after suffering a stroke. Tommy was born and raised in Barker Creek, Michigan where he worked on a farm until he enlisted in the Military in 1948. He spent 23 years in the Army rising to the rank of Master Sergeant. As a fellow Legionnaire, we knew Tommy was a decorated soldier, and it was no surprise when we learned that he received the Distinguished Flying Cross and the Bronze Star during the Tet Offensive in Vietnam. Tommy was a very modest man. Tommy was a giver.

Tommy was legally blind, but he continued to serve his Country through the American Legion. He was our Sgt. of Arms and presided at our charitable donation ceremonies and the annual Williamsburg Memorial Day Ceremony and Parade. Whenever we asked for Tommy's help, he was there for us. And, since

Tommy was legally blind, his wife, Mary Lou Baggs, was his driver. She was always there for him. They were a team that served their community with outstanding dedication.

Tommy's memorial service will be held on Saturday, April 26 at 11:00 am at the New Hope Community Church, 5100 Bethesda Court, Williamsburg, MI 49690. There will be a candle lighting service at Elk Rapids Masonic Lodge #275, 126 River St. (2nd Floor), Elk Rapids, on April 30, 2014, at 6:00pm. Light lunch to follow after service.
