## **Planning Commission News**





Recently, our township has had a lot of questions about who, when, where, and how land can be developed within our jurisdiction. While this can be a very complicated issue, I would like to provide information on how our township addresses two forms of development, Site Condominiums and Planned Unit Developments.

information on how our township addresses two forms of development, Site Condominiums and Planned Unit Developments. A Site Condominium is a development in which a parcel of land is divided into units/lots for the construction of **residential homes** under the Condominium Act. This development must meet all of the zoning rules for residential housing without adjustments. It will typically have some shared ownership of land including but not limited to the roadway or potential open spaces which are eventually managed by a condominium association. It will be reviewed by many state and local agencies, by the Planning Commission under the site plan review process, and eventually by the Township Board for compliance with all of the above. This type of development is discussed in Article 28 of our Zoning Ordinance.

A Planned Unit Development is most often referred to as a PUD. This type of development goes through all the same reviews as a standard site condo but is also evaluated through the Special Use Permit (SUP) process which requires neighbor notification and a public hearing. It allows for the consideration of specific adjustments to zoning standards within the district and is not necessarily residential in nature. Alterations may include mixed uses but are most often used to increase density. When the PUD process is used, the applicant often dedicates a significant portion of land to open space in exchange for increased density known as cluster development. The SUP process is used to ensure that the adjustments will not be incompatible with the surrounding area. This process is addressed in Article 31 of our Zoning Ordinance.

Zoning can be complicated and frustrating at times, but your Whitewater Township Planning Commission remains dedicated to listening to and addressing the concerns of citizens while also adhering to state law as well as our zoning ordinance in these matters.


#### TIPS FOR BEING A GOOD PARTICIPANT IN TOWNSHIP ZOOM MEETINGS:

#### Happy Spring Greetings from the Clerk's Office to all!

Over halfway through April now, we know that warmer temps are in our immediate future! Winter is beautiful in its own way, but nothing beats the "revival" that takes place in nature every Spring when the migratory birds come back, the ground warms up, and greenery and flowers push their way to the sunshine! Hallelujah; it's that time of year!

#### **May Election Details**

It's also time for elections, starting with the May 3rd election to fill the vacant trustee position on the township board. Polls will be open on May 3rd from 7:00 a.m. to 8:00 p.m., or you can receive and vote an absent voter ballot until 4 p.m. on Monday, May 2nd (including from 8 a.m. to 4 p.m. on Saturday, April 30th). If you want to pick up a ballot in person, stop at the Clerk's office with your ID and fill out an absent voter ballot application; it only takes about five minutes. Sorry; election law does not permit us to give you someone else's ballot.

#### **Election Results Modem Process Discontinued**

In an effort to help restore voter confidence in election security, the process of sending election results after the polls close <u>via tabulator modem</u> to the county clerk's office has been discontinued. The modem process allowed the county clerk's office to get the precinct and absent voter counting board results earlier (and thereby provide them to candidates and the news media earlier) after the close of polls. It has always been the procedure that the pollbooks and flash drives were put under numbered seal and physically driven to the county clerk's office on election night after the results tapes are run, reports printed, closing paperwork prepared, and the tabulators put back in storage. Nothing about that detailed post-close of polls procedure is changing; only that the modem step has been eliminated entirely.

#### Do You Have Interest in Becoming an Election Inspector (a/k/a Poll Worker)?

Whitewater Township could use a couple more election inspectors for the August and November elections. Election inspectors must be certified and they receive their certification training through the County Clerk's office. This training is a 2-3 hour commitment and takes place in the summer of even years. Election inspectors must be recertified every two years. Training on the equipment used in elections, i.e., the tabulator, ExpressVote, and ePollbook devices, is handled by my office and takes place in the last couple weeks prior to an election, generally during the evenings. Inspectors must also be available in the afternoon on the Monday before the election to set up the precinct, and of course, must be available for their shift on Election Day. Election inspectors are paid for ALL training, setup, and Election Day time. ## Spring Greetings from Whitewater Township Fire Department

With 124 calls for service, 2021 was the busiest year the Whitewater Township Fire Department has seen in many years and 2022 is already looking like a banner year as our calls are up 107% from this time last year. To make matters worse, our staffing is down as well with two of our firefighters recently leaving the fire service. This trend is not specific to our small town; this is a nationwide issue with no real resolve. Myself and the Township Board routinely discuss options that will protect the firefighters yet provide an essential service. Look for some changes coming to the fire department in the next couple years as we nay

essential service. Look for some changes coming to the fire department in the next couple years as we navigate through these challenging times.

In keeping with spring tradition, I would like to remind everyone to practice safe open burning in our township. Our area again has experienced a relatively short winter with little snowfall and snowpack bringing an early wildfire season. According to the US Drought Monitor, our area is currently experiencing moderate to abnormally dry conditions which is predicted to improve later this spring.

Whitewater Township follows the Michigan DNR and EGLE regulations for open burning. Small fires for recreation and cooking are allowed without a permit in an approved container. However, general open burning requires a permit which can be found online at <u>www.michigan.gov/burnpermit</u>. On the Permission to Burn page, click on the "CAN I BURN TODAY?" link. This will take you to a map of Michigan; be sure to click on Grand Traverse County to see detailed information about each township. If the Burning Permits Issued column says YES next to Whitewater, then you may burn with the restrictions noted. If it says NO, then you may not burn. You may also obtain information by calling 866-922-BURN (2876). Please remember to use caution when burning on windy days, *never* leave your fire unattended, and of course burning trash and construction materials is strictly prohibited.

Please also remember to check your smoke alarms regularly. Last year in Michigan, 107 people died in 94 fires with only 40% of those homes having working smoke alarms. Working smoke and carbon monoxide alarms are essential in every home. If you need help with either of these, please contact the Fire Chief.

**Let's talk roads** - The Grand Traverse County Road Commission (GTCRC) is responsible for the roads throughout the County. As such, when you see pot holes, broken shoulders or rough patches call them at 231.922.4848 or email <u>mailto:gtcrc@gtcrc.org</u> Pictures and an accurate location description are important.

Once GTCRC has knowledge of a hazard they have a responsibility to respond to it. **The Township has no authority or influence to fix roads**. Send **ALL** comments to the entire **Road Commission Board of Commissioners** their email address can be found <u>here</u>. Be sure to include Road Commission **Manager Brad Kluczynski** and the rest of the **Administration Staff** in your comments <u>here</u>. For our friends on gravel roads, as of the middle of April, we do not have any brine pricing or application schedules for control dust. Use the above contacts to express your concerns on gravel roads.

The Planning Commission has been the focus of a lot of media attention as of late. Citizen concerns over the lack of density regulation and loopholes that can be exploited by developers top the list. Please watch for **Community Input Sessions** regarding the Master Plan. **We want your input**! If you have interest in how your community is designed and looks, stop by their webpage <u>here</u> or sign up to have the group's agenda emailed directly to you.

If the rain does stop, **Wildland Fire Danger** will become a major threat to our area, especially during spring lawn clean ups. Before burning, please visit the DNR's website at <u>here</u> to determine if burning is allowed. As an alternative to burning check out the County's brush drop off site <u>here</u>.

**Thank you to all that pitch in** keeping the area around the recycling bins neat and clean! Bins are emptied on **Mondays and Thursdays** if they are full, we ask folks to never leave articles outside of them. Instead, visit another location or simply stop back. We will try to schedule an additional weekly pick up beginning the middle of May to help offset the summer rush. 

The 2022/2023 budget has been completed. The budget process is a lengthy process involving all board members. It is done once a year to plan ahead for the financial well-being and stability of the Township as mandated by state law.
Preparations for the upcoming tax season are underway in the Treasurer's office. We are looking forward to a busy and productive summer and hoping to see many of you at the Annual Cleanup Day on June 11th. My deputy, Lois MacLean, and I will be the ones greeting you and checking ID's as always.

#### **IMPORTANT TAX INFORMATION TO REMEMBER**

**Summer Deferment Applications** can be found on the Township webpage, or a copy can be obtained from the Treasurer's office. If you have had a deferment in the past, one will automatically be mailed to you in May.

**Principal Residence Exemption (PRE)** Affidavits **(Homestead Exemptions)** and **Request to Rescind** are due **NO later than June 1, 2022.** They can both be found on the Treasurer and Assessing webpage tabs or can be picked up here at the township hall. Completed forms should be returned to Assessor Dawn Kuhns.

**Important:** When you receive your July 1st summer tax bill, please open your envelope even if your taxes are being paid by a mortgage company. The July newsletter will be in with your tax bill and will have important information you are going to want to see. If you receive a tax bill that is not yours, please call us so that we can make sure the correct people get their tax bill. We appreciate your assistance with this. *Hope to see you at Cleanup Day*!
