## **County Commissioner Report**

Darryl Nelson gave the following report:

- They have a new board, now 9 members, 5 new members. Went through organization meeting last week. Changed meeting time to 9:00 a.m. on Wednesday rather than 8:00 a.m., re-elected chair and vice-chair. Nelson proposed a volunteer work bee between board members as a way to get to know each other.
- Ended the year big with the ARPA award process. A lot of hours spent by board and community. Could not say yes to 80% of the requests. Giving \$100,000 approximately to Lossie Trail. Public Sector Consultants (PSC) and county admin are going to handle the processing of the paperwork, federal forms. County will help township get through that. They tried to spend the ARPA money around the county and around different

things. Set aside \$5 million for healthcare infrastructure, primarily for mental health. Also have \$3 million from the state. He listed some of the places they spent money.

Those corrections shall be available for the next subsequent board packet after correction. Best practice suggests, but not required, public body minutes without corrections be approved at the next regular meeting after the meeting to which the minutes refer. Minutes shall never be approved automatically or ex post facto; second by Glenn.

Motion by Popp in accordance with MCL 41.72(a) (5) and (6) the Whitewater Township Board of Trustees, not more than 21 days after a meeting of the board, shall publish the proceedings of the meeting in a newspaper of general circulation in the township. The publication of a synopsis of the proceedings, prepared by the township clerk and approved by the supervisor, showing the substance of each separate proceeding of the board; second by Vollmuth.

Motion by Popp that the salary range is between \$38,000 and \$52,000 annually for this position; second by Glenn.

The motion was rescinded.

Motion by Goss that the salary range for the Parks & Recreation Manager position be set at \$35,000 to \$45,000 annually; second by Benak.

Motion by Popp to accept the proposed job description for park manager as amended in discussion here today; second by Glenn.
