Off-peak camping rate: \$39 per night. Peak camping rate: \$45 per night.

Additional adult sleeping unit: \$25 per night.

Reservation fee: \$8 per night.

Ice, wood, and all other rates to remain the same.

2023 dates were discussed as follows:

May 5 opening day, with May 5 and May 6 Free Camping Weekend.

Off-peak rate, May 7 through June 11.

Peak rate, June 12 through September 3.

Off peak rate, September 4 through September 30.

Park will close at 12:00 p.m. on October 1.
