Please help us out and refrain from open burning when burn permits are closed. To check the status of open burning, go to https://www2.dnr.state.mi.us/burnpermits/ and click on Grand Traverse County. This will tell you if open burning is allowed for the


day in our township, but be sure and check this daily before you burn. We also have a link on our webpage https://www.whitewatertownship.org/fire.html

I would also like to share with everyone that we have two new recruits that have recently graduated from the fire academy and are now certified firefighters ready to serve our community. This particular fire academy was completely funded by Michigan Works which has been a great partnership with Northern Michigan Fire Departments. Please welcome Joe Perkovich and Cole Kushner to the team if you see them out working.

The Whitewater Township Fire Department participates in the Michigan Bureau of Fire Services (BFS) smoke alarm program. If you live in Whitewater Township and need smoke alarms in your home, please contact Chief Flynn at 231-267-5969 or email at firechief@whitewatertownship.org. Please remember that smoke alarms need to be replaced after 10 years and Carbon Monoxide alarms are only good for 7 years. We encourage you to check your elderly neighbors and loved ones' smoke alarms often.

July 4th, Honoring the U.S. Flag and Our Countries' Independence

On June 22, 1942, Congress passed a joint resolution, later amended on December 22, 1942, that encompassed what has come to be known as the U.S. Flag Code. What we know fondly as the "Stars and Stripes" was adopted by the Continental Congress as the official American flag on June 14, 1777, in the midst of the Revolutionary War. Colonial troops fought under many different flags with various symbols - rattlesnakes and slogans - "Don't Tread on Me," "Liberty or Death," and "Conquer or Die," to name a few.

Why is the American Flag Red, White, and Blue?

In 1782, the Congress of the Articles of Confederation chose the colors for the Great Seal of the United States with these meanings: * White for purity and innocence * Red for valor and hardiness * Blue for vigilance, perseverance, and justice.

American Flag Etiquette

Did you know that there are special rules for taking care of our flag? The U.S. Flag Code is an official set of guidelines (not laws) that dictates how a flag should be flown in order to show it the respect and honor that it deserves. Let's Talk Cemeteries!

Whitewater Township has two cemeteries. Both cemeteries were established in the 1800's. Here's when and how they came into existence.

In the 1860's, Charles Truman Scofield gave the land for the Cedar Rapids burying ground from his own farm land. At a meeting on September 26, 1868, "for the purpose of taking into consideration the surveying and fencing of the burying ground and the transaction of such other business as might be thought necessary in regard to fitting up the burying ground," resolutions were adopted. "Resolved that J.G. Crisp circulate a subscription paper to see what could be obtained for surveying and fencing the burying ground. Resolved that D.B. Scofield attend to the surveying of the ground."

Then on October 3, 1868, there was another meeting "for the purpose of organizing a burying ground corporation," and the following resolutions were adopted. "Resolved that the burying ground be known as the Cedar Rapids Burying Ground. Resolved that J.B. Rickard be elected president, William Crisp clerk, J.W. Arnold treasurer, and George Brown sexton. Resolved that D.B. Scofield, J.G. Crisp, and J.S. Luce be appointed a committee to draft constitution and bylaws."

The "burying ground" referred to is the present-day Williamsburg Cedar Rapids Cemetery located east of the Whitewater Township Emergency Services Building on Old M-72. Although additional space has been added to this cemetery a couple times, the main part of this cemetery is 155 years old!

On January 4, 1894, David Vinton and Ruth Vinton, husband and wife, dedicated property in Section 4 of Whitewater Township to be surveyed and platted for cemetery purposes, to be known as Circle Hill Cemetery. This property is located approximately 1 mile south of M-72 on the east side of Vinton Road. The sign for the cemetery drive is small and easy to miss. This cemetery is 129 years old!

Even though both of the township's cemeteries are very old, there are still burial spaces available in both of them. The township cemetery ordinance does provide that "cemetery lots or burial spaces shall be sold to only residents or taxpayers of the township for the purpose of the burial of such purchaser or his or her heirs at law or next of kin." There is a provision for variance from this provision in certain circumstances. If you are interested in obtaining a burial space, please contact my office anytime Monday through Thursday, 9:00 a.m. to 5:00 p.m., for assistance.

After living out of state for many years, I wanted to be closer to my family, which brought me back to Michigan.

I have been back in Michigan for many years now and have started a family of my own. I married my amazing wife Brooke in 2015. Since then, our family has grown to a family of six. We are fortunate to have four beautiful, healthy, and energetic young daughters and one great dog.

New Master Plan Well Underway

In the last six months, Whitewater Township has made significant progress toward a new Master Plan. Michigan communities rely on Master Plans to define a long-term vision for growth, preservation, and redevelopment and as a basis for local zoning. Master Plans should be updated every five years, and the most effective and useful planning efforts are those that are thoroughly grounded in citizen participation.

Some initial steps in the planning process included establishing a Resident Outreach Subcommittee (ROS). This group of Planning Commission members and volunteer residents has risen to meet the challenge of determining the best ways to reach residents for input. The first step chosen was the preparation of a new community survey. The last time the community was asked questions to help shape a new Master Plan was in 2009, so a new survey was long overdue. This survey ran until June 16, 2023, and yielded about 600 responses. This return rate is excellent, and it speaks well about our residents who care enough to take the time to complete a survey. As most responses were completed on paper, recording the responses and written comments will take time. Networks Northwest assisted Whitewater Township with hosting the electronic version of the survey, and their staff will tabulate the handwritten responses. Unopened surveys are being delivered to them, and we expect complete results around mid-July.

The completion of the survey is among the first steps in the planning process. It provides important baseline information about local attitudes and preferences. Going forward, however, residents can look forward to more opportunities to weigh in on community planning issues. Once complete survey results are provided and fully considered, the Planning Commission will gear up for one or more workshops to provide more opportunities for a deeper dive into planning issues. Survey results are great, but in-person workshops often provide the best opportunities to learn, converse, hear other points of view, and express your thoughts and ideas. This will be an exciting opportunity to join your neighbors and discuss the future of Whitewater Township. Results from the survey and workshops are foundational to what the Master Plan will say and recommend. Look for more information about events late this summer or early fall.

Also, in the last few months, work has progressed on the initial chapters of the Master Plan. Master Plans generally begin with a description of the community in terms of its history, present conditions, and trends. As of now, the first four chapters have been written for Whitewater Township that provide this information. This material is a working document subject to updating and editing. Comments are always welcome as we try to capture an accurate and factual picture of our community and our larger region. This document is about 50 pages and can be accessed on the Whitewater Township website. The rest of the Master Plan will unfold as we

more clearly hear the voices of residents and learn more about local desires for community development, redevelopment, and preservation.
