#### **Business**

1. O.I.L. Energy Corp. Draft Permit Application Discussion

Chairman Zakrajsek explained that the purpose of the special meeting was to discuss whether the Planning Commission would send a letter to the EPA with regard to O.I.L.'s application for conversion of a Class II injection well to a Class I.

A letter from Brad Boals, 10091 Munro Rd, was received requesting that the Planning Commission request a hearing.

### **Commissioner Comments:**

- After consideration of all of the available information, the change in classification from Class II to Class I for the disposal of cherry waste is of value both economically and environmentally.
- The use of deep injection disposal vs. trucking is preferable.
- Appropriate testing is in place.
- Whether there can be additional sources for waste is the biggest issue.
- The Processing Plant will pipe to the well as opposed to manual transfer.
- The well disposal will allow for cost reductions for processing which could create a trickle down more profit for the growers, employees and facility itself.
- The public hearing will take place regardless of whether Whitewater Township proper takes a position.
- How would the Township and/or residents be notified if changes are proposed?

Chairman Zakrajsek thanked the Commission for perfect attendance on such short notice. Motion by Savage, seconded by Boyd to not send a letter requesting a public hearing but to direct the Planning/Zoning Administrator to send a letter to Leslie Patterson of EPA, Region 5 for the purpose of asking clarification on the following 2 points: 1) the use of "Traverse County" as opposed to "Grand Traverse County," and 2) How can the well allow additional waste sources to be disposed of?
