Approval of minutes:

MOTION by Cosgrove, second by Hubbell to approve November 14, 2022, meeting minutes. Roll call vote: Butler-n/a; Voice-yes; Cosgrove-yes; Melton-yes; Hubbell-yes. Motion carried.

Reports/Presentations/Announcements/Comments/Correspondence:

Boat launch project has been approved to go out for bid.

Unfinished Business:

1. BCNA tree removal – no known board action. Popp stated in the November board meeting he was not going to get quote information from Largent for the additional tree removal. The project was not completed. Largent indicated that the full amount of the "up to" contract has not been maxed out so it would likely fall within the amount still available. Largent indicated that a center line of the trail just needs to be set and he could determine the trees that need to be addressed.

PRAC can get the numbers and present to the board.

PRAC needs to make a determination / decision of when a project is presented to the Board and out of PRAC hands. Melton will contact Largent to get a quote.

2. Lossie Trail wetland improvements, EGLE preconstruction walk through requires a \$100 fee be prepaid. MiWaters website must be used to get the permit. This is the first step that must be addressed before any quotes or estimates can be gotten. Several members of the community have offered to pay the fee to get the project moving.

3. Hi Pray Park playground status update: everything has been completed. Another inspection is not required but will be scheduled and will be completed at no additional charge.

4. Lossie /BCNA trail signage – on hold.

5. Revised Draft bylaws to revise meeting dates – was not submitted to the board in time for inclusion in the December meeting. It has been presented for inclusion in the January board meeting.

6. GT County ARPA grants have been submitted. ARPA submissions list was in the Record Eagle. Public comment at the Commission meeting tomorrow morning, December 14 at 8 a.m. Additional meetings are scheduled for the 21st and 28th. The county hopes to announce on or before the 28th.

7. SPARKS grants – BNA trail improvements related to the management plan, specifically the trail to the beach with the overlook deck and the connect to the Lossie Trail.

Two resolutions were approved by the board for grant submittal. One resolution for BCNA and one for the Hi Pray walking trail. The park beach proposal did not get approved as it needs more detail.

In the first round of SPARKS grants the BCNA project is being pursued.

Will need more information and estimates for the Hi Pray Park walking trail and parking lot. Will get prices. The one

DRAFT

that came through for the trail was for a 10' wide trail. It does not need to be that wide. Will be able to get the information together for the walking trail and park beach grants for the second round.

PRAC board liaison will be Don Glenn.

There is a disconnect between the PRAC and the board.

The board indicated that the PRAC should have more input on projects at the park.

New Business:

Budget items: Have we gotten any input from the board on the "use it or lose it" funding – no roll over allowed year to year? The board can, apparently, change their mind each year. This will be a question for Glenn.
 How can we budget for anything if it cannot be completed in one year?
 Have we gotten any input from the board on what their top priorities are for PRAC to work on?
 Slide, bench, table, infant swing and a play station for the smaller kids at the park playground - \$46,000.
 Lossie Road Nature Trail, reinstate last year's \$25,000 for wetland mitigation.
 BCNA, reinstate lasts year's \$15,000.
 Diamond dust for the ball fields at Hi Pray Park.

October 17, 2022, the board motioned and approved 27.5% of the township ARPA fund for LRNT and BCNA.

Maintenance items for the budget will need to be put together. The trails need a maintenance plan. Recommend the trails and parking areas be mowed three to four times a year.

We will have a maintenance budget and capital improvements budget.

If yes, please explain what features currently exist at the park?

The Battle Creek Natural Area is located at the south end of Elk Lake and includes 255 acres with approximately 2300 feet of lake frontage. This natural area has a variety of diverse habitat and vast ecological systems. Battle Creek is a designated trout stream. Other features include wetlands, a red pine plantation, upland forest and approximately one-half mile of frontage on Elk Lake. There is an unpaved parking lot at trail head. Trail system that extends around to Huebner Pond and Dam. There are two benches, and a spur trail intended to access a future trail toward the beach area including an overlook deck. The Boy Scouts created and placed a bench on the beach, but it is currently inaccessible from land. This beach area is a designated stop on the Paddle Antrim Chain of Lakes Water Trail route. The pond has a damn which feeds into the Battle Creek and continues toward Elk Lake and towards our Lossie Road Nature Trail.

Proposal Description What do you want to do?*

Create a safe, accessible, public natural trail system that includes several improvements that align with the BCNA management plan.

In August 2015 we had a high winds storm that devastated the Battle Creek Natural Area (BCNA) and Lossie Road Nature Trail (LRNT) properties. We received federal funding to compensate for the tree cleanup, but unfortunately the spur trail that went to the lakeshore could not be recovered. In 2020, during the pandemic we had an increase in public interest and usage in our natural trail systems. August 2021, the BCNA and LRNT properties experienced another high-wind storm event that ravaged the trails and caused over 140 fallen or leaning trees to be directly within the walking path. The township board approved \$67,200 to help mitigate both trail clean-up projects, but the project was not fully completed due to additional unknown areas that were damaged. The devastation of these areas made it practically impossible to walk through the entire trail system at the initial assessment. The township hired a professional arborist to create a Hazardous Tree Inventory report. We were able to contract the work of the Grand Traverse Conservation District (GTCD) for the main impassable trails. However, we have more work to clear the spur trail section to the lakeshore and beyond the pond trail. The Parks and Recreation Advisory Committee (PRAC) has engaged with the Grand Traverse Regional Land Conservancy (GTRLC) and the GTCD to partner with this project and other needed trail improvement projects. The township board has also approved some local ARPA funding to create a loop trail system on BCNA property.

This property was acquired in partnership with the Grand Traverse Regional Land Conservancy in 2007 and the township adopted the BCNA Management Plan in 2008 and later revised in 2010. There was also a property just south acquired by the township in 1992 that is also incorporated in this management plan called Lossie Road Nature Trail.

Our goal is to create a safe, accessible, public natural trail system that includes these improvements:

A. completion of a trail toward the Elk Lake water frontage

B. addition of an overlook deck

C. addition of educational signs and markers

D. create a connector trail to our Lossie Road Nature Trail

E. parking lot improvements

A. Currently, the BCNA spur trail that was intended to allowaccess to the water is inaccessible due to storm damage and wet areas. The old trail (prior to 2015) was so devastated that it could no longer be found. There was a spur trail recreated off the main trail after this 2015 storm but was never completed due to the extensive damage and funding. This project would incorporate the cleanup of this existing trail and tree removal for approximately a half-mile to create the newtrail allowing access to the water. We would like to work with the Grand Traverse Regional Land Conservancy (GTRLC) to recreate a low maintenance, natural walking trail. Using natural vegetation and tree cover to improve the path and reduce erosion will allowfor the lowest amount of ongoing required maintenance.

B. The BCNA Management Plan includes a specific requirement to add an elevated overlook deck at the water and has been on our Recreation Plan Capital Improvement list. This deck is to be 20ft by 30ft and made from treated wood. This will have railings for safety and appropriate signage. C. We would like this natural area to be a learning environment for children and the general public. We plan to add several educational signs providing details of the habitat, trees, animals, and water attributes.

D. The BCNA Management Plan also includes a trail connector between the BCNA trail and the LRNT. Whitewater Township has an existing trail system just south of the BCNA properties, called Lossie Road Nature Trail. There is a short section where these properties do connect, which would be ideal to create a natural walking trail connection. This area has heavy tree overgrowth and fallen trees, which would be opened up when creating this trail system. The Battle Creek runs from Huebner Pond into this LRNT property. It would be ideal to create this connector trail along this creek bed giving the most beautiful views and accessibility to fisherman.

E. Our parking lot is currently unpaved and uneven. We would like to create better signage and flat ground for ADA accessible parking spots.

1. Public benefit and anticipated outcomes

1a. How was the community negatively impacted by COVID? How does this project address that? (Maximum of 10 Points)*

Our community was affected by COVID in many ways; lost jobs, isolation causing loneliness, depression, addiction and general reduced mental and physical health. According to Mental Health America, within the last two years during the pandemic, 5.4 million people took a mental health screening, a 500% increase. From these screenings, 76% of US citizens were positive with moderate to severe symptoms of mental health conditions. Due to the increase in mental and physical health issues, our healthcare systems were and still are put under extreme strain.

It has been proven that individuals spending time in nature are happier, healthier and have less stress. They are less likely to display anxiety disorders, depression and more likely to report high levels of happiness and well-being. A healthy community leads to fewer hospitalizations, putting less stress on our healthcare systems. BCNA trail system is an incredible natural area that helps with mental health as well as education. We have several local schools and preschool programs who could potentially use this area for field trips to create a learning experience about science, environment, wildlife, geology and ecosystems. This provides free education to our surrounding community and school districts about the habitats in the area and being outdoor helps with the mental and physical health for everyone. Lastly, they provide a cost-free way to exercise and be together with family and friends.

1b. How will this project contribute to strong healthy communities that promote health and safety? (Maximum of 8 Points)*

After the pandemic began, many individuals became very cautious to be in public. These outdoor natural areas and trails allowed for safe distances to be healthy. This project will provide healthy, safe, and free natural walking trails, which improves mental health and provides educational experiences. Being a beginner trail level, it accommodates all age groups and people with slight physical and mental disabilities. This will also afford families a unique and local place to use these trails to create adventures and memories that will last.

Anyone who has the interest in walking, biking, cross country skiing, or snow-shoeing through a beautiful untouched natural area will benefit. This natural area is also open for hunting and fishing activities, which can only be accessed safely through these trails. The trails give a place for young students to go and get away from electronics, which leads to natural learning. This also provides a healthier environment for them to breath clean air, stretch and exercise. The families, hunters, and everyday outdoors people will all benefit.

Green areas help with carbon emissions making the environment a cleaner healthier place. Our watershed also keeps our lakes filtered, increases biodiversity, carbon storage, nutrient cycling and so much more.

Due to the extreme wind damage there are many trees that have fallen or are leaning over these trail systems, which is a huge safety concern for walkers. This project will address this issue.

1c. What kind of stakeholder and community input did you have? (Maximum of 4 Points)*

The Parks and Recreation Advisory Committee (PRAC) had a public input process during our updated 5-year Recreation Plan of 2020 to evaluate the needs and wants of the community. Part of this was a public survey that resulted in a high rating of natural walking trails and specifically for the Battle Creek Natural Area and Lossie Road Natural Trails. The township also conducted an ARPA survey September 15, 2022, which resulted in Parks and Recreation improvement projects being the 4th most important to the community. Based on both extensive public input measures, it is very apparent the community wants safe natural trails to enjoy with their families.

We have been working with guidance from experts, such as the Grand Traverse Conservation District, the Grand Traverse Regional Land Conservancy, and the Michigan Department of Environment, Great Lakes and Energy. We have met with the GTRLC several times to discuss strategies on creating a more sustainable trail, improving it by creating a safe path to regain access to the ½ mile of inaccessible beach area. We hope to work with EGLE to evaluate the watershed and ecosystem of this natural area to keep these clean and safe, which will keep these areas green and reduce carbon emissions in the area.

We are also addressing the BCNA Management plan to improve the path to the beach area, provide the deck overlook, and making a connector trail to LRNT

Whitewater Township does have an updated 5 year Parks and Recreation Plan, valid for 2021 through 2025, filed on the MiGrants website. This project is currently included on this plan as item 6 and 7 on our capital improvements project list. The first 5 projects either have been completed or are in process through other funding.

Currently, we are a designated rest stop for the Paddle Antrim Chain of Lakes Water trail system. The Chain of Lakes Water trail is a 100+ mile inland water trail made up of 12 lakes and interconnected rivers, which flowinto the East Grand Traverse Bay of Lake Michigan. There are 20 access site owners and 84 access sites. The Battle Creek Natural Area is one of these designated rest stops along this route.

After this project upgrade, we hope to partner with the local schools, Cub Scouts, Boy Scouts, Girl Scouts, and other educational programs. The educational trail markers will provide a learning experience that would have a great potential for daytime field trips. The Scouts could utilize this natural environment for some of there learning and earning badges. They use outdoor exploration to teach Character Development, Citizenship, Personal Fitness, and Leadership skills.

There are other trail system apps that we hope to get added to such as; Trail Link, Outdoor Active, AllTrails, GAIA GPS, etc.

5b. What specific features make your project unique and can clearly show that input from the above groups has been incorporated?* (Maximum of 10 Points)

This is the only natural area and unimproved beach on Elk Lake that is accessible by the public. This one-half mile of frontage on Elk Lake is the longest undeveloped shoreline remaining on Elk Lake. This project would provide access to the striking views of this shoreline with the addition of the trail and overlook deck. When the GTRLC assisted with the acquisition of these properties, we were given a management plan to encourage some improvements. Unfortunately, we have not had any direction, assistance or funding to further this until recently. With the help of Steve Lagerquist with the GTRLC, we have re-engaged our township and board to make these improvements. This project specifically addresses the trail spur toward the shoreline, the overlook deck, the connector trail to Lossie Road Nature Trail, as well as parking lot improvements for people with all abilities. We already have a natural trail (LRNT) just south of the BCNA property that does not connect. This proposed 3⁄4 mile connector trail from BCNA to the LRNT trail system will encourage more community experiences and opportunities to explore the combined 7-mile trail systems and Battle Creek itself. This simple connector will allowaccess from Cook Road all the way to the pond and the lakeshore.

This project is very much in line with our community input from the attached (5a.) survey from 2020 and clearly shows their input has been incorporated. There are many positive comments regarding our natural trails and properties and specifically to the much-needed improvements to the BCNA trails. See the files under additional information that include our 5-year Recreation Plan including the BCNA Management Plan as well.

We will rely on the engineer to recommend the most sustainable design and materials for this project overall. The overlook deck, bridge, and boardwalks will utilize materials rated for longevity and reduced maintenance. For instance, we will investigate the deck material for vater shedding and drainage properties in order to prevent safety and maintenance issues. Updated signage will help maintain the trails by increasing the level of usage and general community knowledge of these great natural resources. We would like to work with the GT Regional Land Conservancy to help with modifying existing trail in creating this connecting loop to be more 'natural' and sustainable. There is more tendency for people to walk a trail to a beautiful overlook destination. More walkers will create natural footpath instead of an open pathway that requires moving and more maintenance. As the newtrails are designed, we will create the routing to make these trails with the least amount of boardwalk.

It is anticipated that increased trail usage will result in more communication by users reporting trail maintenance issues, such as downed trees, debris, water levels, deck/boardwalk concerns or garbage that would require immediate attention. The sooner we knowabout needs, the quicker we can support manpower and funding to keep up with safe trail management.

As the community usage increases, it will be important for the township to include additional funds in a yearly budget for maintenance and future improvements. Based on the feedback and support of the community from our recent surveys, this will also help promote future trail improvement projects. We also have good neighboring community members who have volunteered to clean up or communicate to the township areas needing maintenance.

Bylaws

The following rules of procedure are hereby adopted for the Whitewater Township Parks and Recreation Advisory Committee to facilitate the performance of its duties as outlined by the Whitewater Township Board of Trustees and General Ordinance No. 48.

SECTION 1: Membership

- **A. Membership Size** The Parks and Recreation Advisory Board shall consist of five (5) members.
- **B.** Membership Terms of Office Members are appointed by the Whitewater Township Board of Trustees for staggered three year terms and expire on December 31. Members are expected to serve until their term expires and a successor has been appointed as provided above.
- **C. Membership Departure** Members who are unable or unwilling to serve the entire terms for which they were appointed or who do not wish to be considered for reappointment shall provide sixty (60) days advance written notice of that fact to the Whitewater Township Board of Trustees so that a successor may be appointed and approved in a timely manner that does not require the Committee to function with less than the five (5) members provided.
- **D. Membership Qualification** All members shall be either qualified electors of the Township of Whitewater or a property owner within the Township.
- **E.** Liaisons The Township Parks and Recreation Administrator (including agents or consultants) shall have the ability to participate in discussions of the Committee during their meetings.

Section 2: Officers

A. Selection and Tenure At the first regular meeting each January, the Parks and Recreation Advisory Committee shall select a Chairperson and Vice Chairperson. A recording secretary will be provided by the Township Board of Trustees. All officers shall serve a term of one year, and shall be eligible for re-election for consecutive terms for the same office. The newly elected officers shall assume their responsibilities at the next regular meeting. If due to unforeseen circumstances, the Parks and Recreation Advisory Committee is unable to elect officers at the January meeting, those officers whose terms as officers have expired and who remain as active members of the Parks and Recreation Advisory Committee shall continue their services as officers until elections are held.

- **B.** Chairperson The chairperson shall prepare the agenda for the meetings with assistance from the Park and Recreation Administrator and shall preside at all meetings and perform such other duties as may be ordered by the Township Board of Trustees.
- **C.** Vice Chairperson The Vice Chairperson shall act in the capacity of the chairperson in his/her absence.
- D. **Recording Secretary** The Recording Secretary will be appointed by the Township Board to record the discussions, recommendations and actions taken by the Committee. The Park and Recreation Administrator may be appointed to this position by the Township Board of Trustees.

SECTION 3: Meetings

The business of the Parks and Recreation Advisory Committee shall be conducted at a public meeting held in compliance with the Open Meetings Act.

A. Regular Meetings Meetings of the Parks and Recreation Advisory Committee shall be held on the second Monday of each month. All meetings shall take place at Whitewater Township Hall, 5777 Vinton Road, Williamsburg, MI 49690 at 7:00 P.M. When a regular meeting falls on a legal holiday or upon a day resulting in a conflict, the Parks and Recreation Advisory Committee shall, if possible select a suitable alternate meeting date in the same month as the originally scheduled meeting. If a meeting is to be held at a location other than the Township Hall, notice shall be posted at the Township Hall and on the Township website.

Notice of regular Parks and Recreation Advisory Committee meetings shall be posted at the Township Hall each year in accordance with the Open Meetings Act and on the Township website.

- **B. Special Meetings** Special meetings may be called by the Chairperson or upon written request to the Parks and Recreation Administrator by at least two members of the Parks and Recreation Advisory Committee. Notice of special meetings shall be given to the members of the Parks and Recreation Advisory Committee at least 48 hours prior to the meeting. Such notice shall state the purpose, time and location of the special meeting and shall be posted at the Township Hall and on the Township website in accordance with the Open Meetings Act.
- **C. Agenda** The chairperson shall be responsible for preparing a tentative agenda, with the assistance of the Park & Recreation Administrator, for Parks and Recreation Advisory Committee meetings. The agenda may be modified by quorum of the Committee. In the instance of a special meeting, the agenda may be modified only with all members present at the meeting and in agreement.
- **D. Quorum** Three (3) members of the Parks and Recreation Advisory Committee shall constitute a quorum for transacting business.
- **E.** Voting Actions or motions placed before the Parks and Recreation Advisory Committee may be adopted by a majority vote of the members present and voting, as long as a quorum is present. Voting shall be by voice vote; a roll call vote shall be required if requested by any Committee member or directed by the Chairperson. Except in the case

of conflict of interest, all Parks and Recreation Advisory Committee members, including the Chairperson shall vote on all matters.

- **F. Public Records** All meetings, minutes, records, documents, correspondence and other materials of the Parks and Recreation Advisory Committee shall be open to public inspection in accordance with the Freedom of Information Act, except as may otherwise be provided by law.
- **G. Parliamentary Procedure** Parliamentary procedure in Parks and Recreation Advisory Committee meetings shall be governed by Roberts Rules of Order.

SECTION 4: Duties of the Parks and Recreation Advisory Committee

The Parks and Recreation Advisory Committee shall perform the following duties:

- **A.** Prepare, review and update a Recreation Plan as a guide for development of recreation areas within the Township's jurisdiction.
- **B.** Prepare an annual report to the Township Board of Trustees of the Parks and Recreation Advisory Committee's operations and the status of planning activities, including recommendations regarding actions by the Township Board related to parks and recreation.
- **C.** Perform other duties and responsibilities or respond as requested by any Township Board or Commission.

SECTION 5: Absences and Removals

- **A.** To be excused, members of the Committee shall notify the Parks and Recreation Advisory Committee Chairperson or the Parks and Recreation Administrator when they intend to be absent from a meeting. Failure to make this notification prior to the meeting shall result in an unexcused absence.
- **B.** Members may be removed by the Township Board of Trustees for misfeasance, malfeasance or nonfeasance in office upon written charges and after a public hearing.

SECTION 6: Conflict of Interest

During the Declaration of Conflict of Interest portion of the agenda, Parks and Recreation Advisory Committee member (s) shall disclose the potential conflict of interest to the Committee. Failure of a member to disclose a potential conflict of interest as required by these bylaws constitutes malfeasance in office.

In the event that a conflict is declared, the member shall remove themselves from the meeting table until the agenda item is concluded.

SECTION 7: Compensation

Parks and Recreation Advisory Committee Members and the Recording Secretary will receive compensation on a per meeting basis as determined by the Township of Whitewater Board of Trustees. Advisory Committee Members may receive reimbursement for travel and expenses with recommendation by the Advisory Committee and approval by the Township Board of Trustees.
