VOTER IDENTIFICATION REQUIREMENT IN EFFECT

Every Michigan voter who offers to vote in the polls must comply with the requirement by showing picture identification or signing an affidavit attesting that he or she is not in possession of picture identification. (See MCL 168.523 for picture identification requirement)

Contact your local clerk and request an absentee ballot for a particular election or get on the permanent ballot list and a ballot will be mailed to you for every election.
