The last day to register to vote in any manner other than in-person with the local clerk is **February 12, 2024**

In-person registration with the local clerk with proof of residency period is **February 13, 2024, through 8:00 p.m. on February 27, 2024**. Election Day registrants may apply and vote an absent voter ballot in person when registering at the clerk's office.

The city and township clerks of Grand Traverse County will be at their offices during their regular business hours and additional special hours the weekend before the election, for the purpose of taking applications for registration from qualified persons. No one may vote in the February 27, 2024, Presidential Primary Election unless they are on the registration roll of the city or township clerk by 8:00 p.m. election day.
